
According to the Judicial Department of the Supreme Court of the Russian Federation, 6494 graduates of the University were employed in the judicial system of

The head organisation of the Consortium of organisations from near and far abroad countries providing training, professional retraining and (or) advanced training for judges (since 2021).

Federal innovation platform of the Ministry of Education and Science of the Russian Federation entitled: "Training, professional retraining and (or) advanced training of judges, including judges from near and far abroad countries, using a digital educational environment" (since 2020).

Training centre for foreign judges and court staff (since 1998).



On 5 December 2021, a Consortium of organisations from near and far abroad countries providing training, professional retraining and (or) advanced training for judges and civil servants was established.



The participants and partners of the Consortium are 5 foreign organisations in the area of University activities:

- Academy of Justice of the Republic of Armenia
- Institute for Retraining and Professional Development of Judges, Prosecutors, Courts and Justice Institutions of the Belarusian State University
- Institute for Advanced Training and Retraining of the Investigative Committee of the Republic of Belarus
- **Output** Higher School of Justice of the Supreme Court of the Kyrgyz Republic
- Academy of Justice of the Supreme Court of the Republic of Kazakhstan.

On the Consortium's basis, in June 2022, the International Association of Teachers and Students in Philosophy of Law was established, which has become an intellectual scientific platform for leading Russian and foreign scholars to discuss topical issues in the philosophy of law, such as:

- The importance of the philosophy of law in understanding contemporary legal phenomena
- Levels of cognition of law: issues of methodology
- The language of law as a subject of study in the analytical philosophy of law
- Philosophy of law as a branch of knowledge

- 40.04.01 Jurisprudence (Master's Degree)




