Requirements for the design of the articles: font - Times New Roman, font size (size) - 14, spacing - single, justified, all fields 2 cm each. The text of the manuscript should include: initials and surname of the author (or authors); the article of the title; abstract; keywords; initials and surname of the author (or authors) in English; the title of the article in English; abstract in English; keywords in English; cited bibliographic list (built in alphabetical order or as mentioned in the text). References to the sources should be placed in the text in square brackets in Arabic numerals, indicating a number of the source in the bibliographic list. Quotes should contain a link to the page(s).

A program of the conference will be sent after accepting of applications.
